## WILLIAMSON COUNTY EDP HIRES FIRST EXECUTIVE DIRECTOR

The Williamson County EDP was established in 2014 as a 501 (C6). In the Spring of 2022 due to the growing amount of economic development activity the Board decided it was time to "activate" and hire a full-time executive director. Dave Porter was retained as a consultant in the summer of 2022 to determine a strategy for funding and new lead generation for the EDP. Williamson County stepped up in a big way to assist with funding as well as the eight partner



cities (Cedar Park, Leander, Georgetown, Liberty Hill, Jarrell, Round Rock Chamber of Commerce, Hutto and Taylor). The Partnership asked Porter to become the first Executive Director. On October 1, 2022, the Partnership was officially launched.

## WILCO EDP HOSTS SITE CONSULTANTS EVENT

March 23 - 25, 2023

Hosting consultants that do national and international site selection analysis for companies looking at expanding or relocating is a great way to showcase the many assets Williamson County and its cities have to offer. The Partnership hosted five consultants for a two-day event that included a helicopter tour of the county and cities as well as panel discussions around workforce development



and Why Williamson County (employers panel). The fun portion of the event was spending part of the day attending the Dell Technologies PGA Match-play event held at the Austin County Club.

## FIRST WILCO DELEGATION TRIP TO KOREA

The primary purpose of this trip was twofold: 1) to thank Samsung leadership for their investments in Taylor, and 2) to begin establishing relationships with Samsung suppliers and government organizations. One of the meetings was with the leadership of KOTRA (similar to the U.S. Department of Commerce). A partnership was requested by KOTRA with Williamson County.







